Over 30 bands, market stalls, a warm spring day. Sounds perfect. Almost too perfect.

4ZzZ's Cybernana Market Day was held on the 19th of October 1996.

It would be a lie to say that there had never been trouble at a Zed event before, in fact there is regularly trouble at Zed events - rather strange when exactly the same crowd goes to lots of other events that run perfectly smoothly, but I'll try to keep the conspiracy therories to a minimum.

There are two things which are really important to note - one, we really like the people who support us, and two, without Market Day Triple Zed can not financially survive.

It is for both of these reasons that the station busts it's gut twice a year to make sure that Market Days run smoothly.

Planning starts at least three months before the event, and there is

extensive liaison between Zed volunteers and the police to set up a set of procedures to be followed in case of any trouble.

Cybernana Market Day was one of the smoothest in recent memory. The crowd was nice and mellow, it wasn't too hot, and even the bands were on time.

Then, at around 8.30pm, it started to rain.

Lets just say the procedure we spent months setting up was conveniently forgotten by the police on October 19.

Now maybe it's illegal to play in the rain in Queensland, and the police just forgot to tell anybody.

Or maybe someone decided to give Triple Zed a little message, and didn't trust Australia Post.

Or maybe our friends in blue overreacted.

Reasons were the least of our worries on that particular Saturday night. When it started raining, the bar tills were closed down to prevent people being electrocuted, as was the power to the stages. This, as far as we were concerned "temporarily" closed the event, but as we had a licence to be open until 10pm, if the rain cleared we had every intention of re-opening the stages and bar.

That didn't quite Public Safety Response really quickly and it arrived.

According to a Queensland Police Service press release issued the day after Market Day, it took only 75 minutes for the entire incident - including arrests and crowd dispersal, to take place. It has been alleged that it takes approximately two hours for the normal and mounted police to arrive at an area when trouble starts - but I guess they were out for a nice drive/ride and just happened to be in the area.

Another interesting point is that Triple Zed's Market Day was the first time since the 1976 raid on the Cedar Bay hippie commune that the federal military have participated in a purely state policing matter.

The Minister for Defence Senator Robert Ray said in February 1995 "Law enforcement tasks such as dealing with civil unrest are the province of state and territory law enforcement authorities. It is not envisaged that the Defence Force would be used to assist with such tasks except in the most extreme circumstances, and then only after all other alternative means of dealing with the problem had been exhausted."

I guess six military police cruising the area and deciding to pop in and help out their mates in blue is a "most extreme circumstance". Especially as the military allege there were only 5 officers present, that they did not participate in arresting anyone - didn't in fact lay a hand on anyone (if they did they broke the law and can be charged with assault and sued!), and have since found that there was no improper conduct by military officers. I think the white paint is still wet on that one.

In the few days after Market Day confusion reigned. We didn't know how

many had been arrested, what they were arrested for, how many were hurt, and how badly, and what the repercussions were going to be.

We have since found out that 72 people were arrested on 91 charges. That makes great headlines/news grabs/pictures. What wasn't reported so heavily was that 39 people (over half) were arrested for "indecent manner" which sounds like a dodgy sex charge, but is actually nothing more than relieving yourself in public aka pissing in the park.

Five people were charged with "riotous manner" - a charge that has not been used since the 1930s. Six people were charged with "assaulting police". So of 72 people arrested only six were charged with something resembling a violent act (hitting back is illegal). Five were charged with a questionable law that hasn't been used for 60 years. More people (nine) were charged with abusive or obscene language than were charged with a "violent crime" - of course, Zed listeners know all sorts of words that the delicate ears of the police have never heard before, so that's hardly surprising. And 39 people were arrested because they didn't line up for the toilet. One hell of a riot huh!

Since the 19th of October Zed volunteers have been working to sort out the mess.

After collecting witnesses, we have complaint to the Criminal as this is our only means

We have helped put in contact with solicitors to defence. We have had our unusual position of issuing



statements from brought an official Justice Commission, of legal recourse. "Market Day Victims" help in their legal journalists in the press releases

instead of reporting on them. And we have been both praised and slagged of in the mainstream media.

You might find it interesting to know what the Police Union President thinks of you. On the 25th of October Gary Wilkinson was quoted in the Courier Mail as saying "it has been proven through their (read "your") actions that they cannot act like ordinary, civilised persons". Of course, the police and their batons were both ordinary and civilised throughout the 75 minutes they beat their way out of the park. Mr Wilkinson also alleges people stole officers' watches from their wrists and tried to steal their pistols - which of course would explain why no one was charged with theft or attempted theft. No one was charged with arson either, despite Mr Wilkinson's assertion that people tried to set fire to a police car - no mean feat in a torrential downpour.

Media interest has died down in the Market Day fiasco, but people are still appearing in court, and copping fines, and getting convictions because they decided to support their local radio station, have a few beers and listen to some great bands.

This is wrong.

We have to do what we can to make sure this doesn't happen again - to us or anyone else. If you saw or experienced police brutality on the 19th of October, please contact the station on 3252 1555. The more people who present statements to the CJC the better our chances of being believed.

Thanks to everyone who phoned, dropped in, subscribed etc. as a sign of support. The next Market Day is happening in March, so we'll see you all there!

The Jazz Show

"Any attempt to define jazz is arbitrary. (Guidelines formulated at annual conference, public jazz broadcasters, Washington, 1978).

"Being a good programmer requires both a close (and long) association with the music, and a degree of marketing savvy, plus the integrity that refuses large compromises of either" ("The sorry assed state of Jazz Radio" - Down Beat, June 1995).

Jazz radio is the key to a renaissance of this music, and 4ZzZ is serving in this regard on Mondays with presenters Rod Ferguson, and state jazz authority Sid Bromley. The Mens' Show

The Mens' show started in January 1996 and at the moment is the only radio show of it's kind in the country. The program is produced and presented by a collective of 6 men and airs on Wednesdays from 6-7pm.

A central concern of the show is to offer an alternative to the reporting of men's issues by the mainstream media. The 4ZzZ Mens' show is interested in a critical examination of masculinity, which includes acknowledging the power issues of gender. The show promotes questioning and exploration of gender issues and masculinity, and stresses the importance of working with women to end gender injustice.

The show usually higlights a gender related topic each week. Some topics may be specifically with a focus on "masculinity", others are broader, depending on what's been happening. CORRECTIONS FORUM 1996

On the 21st-22nd of November, Prisoners' Legal Service held a Corrections Forum at the Mercure Hotel in Brisbane.

Presenters of 4ZZZ's Prisoners' Show wrangled an invitation under the title "PRESS" (as we couldn't scrape up the registration fee) and were initially told we could observe but not participate in discussions during the plenary sessions.

Russell Cooper opened the conference and gave the standard political rant on improvements to Corrective Services since his party came into power (the abolition of the Black Hole during his last term as Minister is still in the forefront of his speeches...not much to boast about since then hey Russ ?).

The first of the four topics up for discussion over the two day period was "Prison Reform in Qld : a review of progress since the Kennedy Report of 1987". This proved to be a long-winded diatribe by most governmental representatives, setting the precedent for the conference, with the most valuable contributions coming from the floor,

rather than from the "experts", who, after presenting their prepared s p e e c h e s found little comfort in answering

questions.

However, there were some interesting points, including the fact that there were no detox facilities for users entering prisons and the QCSC has not yet embarked on a policy of harm minimisation despite continued pressure from outside community groups. It was also mentioned that the Deaths In Custody Reports are still not public (for reasons of security ??!!) - this was to be reviewed at a December board (bored ?) meeting ; and there are no inquests in the case of murders in prison, and also that under the cuts to ATSIC, the first section to suffer is that of prison welfare.

The second segment of the forum, "Privatisation of Correctional Centres and Facilities", resembled a conference of used car salesmen rather than a critique and comparison of correctional services. Stan Macionis, QCSC, whose bid for the new Woodford development was successful. detailed his rationales for moving toward privatisation (or "contract management by the private sector" as he prefers to call it): specifically cost and dynamic security. By Stan's own admissions, government-run centres are not cost effective; and as to security. Stan expects custodial staff to have substantial interaction with offenders in the private sector. A strange expectation considering prisons in the southern states managed by the same companies as those attending this forum, have a tendency in moving towards electronic surveillance and

security systems, rather than employing more personnel, in a bid to cut wage costs and therefore increase profit.

Enter the salesmen... Brian Dickson, Corrections Corp. Aust., (owned by C.C.A. America, and French company, Sodexho) management of Borallon correctional Centre; Greg Howden, Australasian Correc-

tional Management, (owned by American company, Wackenhut, whose board is dominated by former police and military officers. Wackenhut has also been fined in the U.S. for misuse of taxpayers funds in both New Mexico and Texas.) and management of the Arthur Gorrie R&R Centre; and last, but by no means least, Stephen Twinn, Director of Group 4, (a British based security company, renowned



Radio Times Summer 96-97 strikebreaking and removal of picket lines) who took our wanker award of the day (and possibly the entire conference). Mr Twinn was the king of rhetoric and must have eaten a crate load of laxatives before flying up from Melbourne, considering all the shite he spoke. Group 4 at this stage have no involvement in the prison system in Qld (although they operate prisons and

prisoner transport facilities in Vic. and S.A.), however their presence at the forum and the fact that the new Women's facility at Wacol is open for tender suggests we may be hearing and seeing more of them.

This brought day one of the forum to an end with the sounds of cash registers and hands rubbing together with glee.

In the final session of the conference, the big guns were called to account for "Prison Overcrowding".

In the blue corner we have the men that fill and administer the prisons, Keith Hamburger, Director General QCSC; Judge Eric Pratt (District Ct. Qld); and Royce Miller, Director Public Prosecutions; while in the red corner, all on his lonesome, was Public Defender, Mike Shanahan.

In amongst all this was statistic whiz, David Brereton, Director, Research and Co-ordination Division, Criminal Justice Commission (C.J.C.), who gave a run down of crime and sentencing stats. which we won't attempt to repeat here.

Hamburger pointed out there had been a 71% growth in Qld. prison populations in the last 3 years, currently at a level of 141 inmates per 100 000 head of the population, almost twice that of the current Victorian rate.

Pratt conceded we need to work towards a proper system of professional classification of prisoners and apt adequate sentencing, that is, not all inmates need be tarred with the same brush and that there was a need to recognise true incorrigibles, which form only a very small percentage of the prison population. He estimated that over 90% of all recorded crime comprised of offences against property in which no personal violence was used; those offences involving personal violence, which include murder, wounding, assault, etc., account for just 6%, the most serious of these, less than 1% of recorded



offences. Pratt went on to say that "nothing much can be achieved by any system unless the community itself is prepared to receive back prisoners with love and understanding".

opportunity to see how the minds of the powers behind the prisons system work, we were left wondering whose pocket we were pissing in, as it seemed to be the order of the day. Most was gained from the comments of those from the floor rather than the puppets and bureaucrats on the panel (with a few exceptions).

It is yet to be seen whether any of the recommendations arising from the forum will ever find their way from the "too hard basket" into relevant and meaningful legislation.

If recent press reports dealing with the proposed extension of prison sentences is any indication of the priority afforded to prison reform, don't hold your breath.

Market Day, The Police, and the Rape Mentality

I was listening to an interview on 4ZzZ with a police representative about the Market Day. The interviewer (Heather, I think) was talking about how 4ZzZ organisers were threatened with arrest when trying to negotiate with police. There had been a prior agreement to negotiate with zed organisers if there was anything going on. When he was asked about the threats of arrest, the spokesperson replied "oh, it was too late by then".

The question immediately springs to mind. "too late for what?". Too late to stop bashing people with truncheons? It made me think of the myth that men rape because our sexual urges are rampant and uncontrollable. Once violence by the police was initiated, is he saying that the police were then no longer able to control their own actions? Just as the rape mentality holds that once a man's sexual interest is aroused, he can not be held responsible for what he does, so the police seem to be saving that once one violent act was perpetrated by the police, it was "too late" to stop being violent. When we explode the myth that rape is about sex, and realise that rape is an act of abuse, domination and control. the exercising of power over one person by another or others, then the actions of the police start to fit an all too familiar and horrifying pattern.

The police's actions on Market Day were consciously chosen and perpetrated by men with truncheons and guns (there was apparently one officer who refused to take part in the violence). The crowds behaviour was having no adverse affect of anyone, and certainly would not have had any effect on the police officers if they had not decided that people were having fun and "no sir, we don't like it". The people at the concert can not be held in any way responsible for the behaviour of the police. The situation was one of complete power imbalance in every sense. Physically, legally, and emotionally (the sight of the police is terrifying at least), the police held power over the crowd, and chose to abuse this power by violently attacking the crowd. However, the police say "it was too late", as if the crowd had power over them and they had to control people. Just as the rapist mentality will blame the appearance, dress, or behaviour of the victim to justify their own actions and need to exercise power and control over another person. The crowd did not willingly and passively submit to the demands of the police, and so the crowd were then deemed responsible for whatever the police themselves did.

I should say here that I am not drawing any similarities between the experience of a rape victim and the experience of the crowd at Market Day I am talking about the mentality of the police and the similarity to the rapist mentality. The rapist mentality appears everywhere in our culture explicitly in pornography and places like court rooms hearing rape trials (it is usually the victim who is put on trial - here is another connection remember who was put on trial in the Pikenba case?). The rape mentality also appears in institutions which are set up to control people who are deemed to be irresponsible, irrational, or uncontrollable (all of which have been and are applied to women as a class, by men who have the power to define such things, and the men who collude actively or through silence). Such institutions include the legal system, psychiatry, social security and the police force.

What happened at Market Day displays the police force's complete inability (and unwillingness) to provide whit it's rhetoric promises. Protection. But who protects us from you? Cameron - 4ZzZ Men's Show
